A Driving Test for Autonomous Vehicles?

> "... Testers need to consider other vehicles as adversaries, and develop plans for extreme situations. For instance, what should a car do if a truck is driving in the wrong direction? At the moment, self-driving cars might try to change lanes, but could end up stopping dead and waiting for the situation to improve. Of course, no human driver would do this: A person would take evasive action, even if it meant breaking a rule of the road, like switching lanes without signaling, driving onto the shoulder or even speeding up to avoid a crash.

Self-driving cars must be taught to understand not only what the surroundings are but the context: A car approaching from the front is not a danger if it's in the other lane, but if it's in the Tech giant Google has car's own lane circumstances are entirely different. Solo at Qualcomm




